TOURING OUTREACH SERVED 21 DISTRICTS, 176 SCHOOLS AND 88,000 STUDENTS HAD ACCESS TO OUR VIRTUAL TOURING OUTREACH PRODUCTION OF THE P-FUNK POSSE. THIS OUTREACH EFFORT INCLUDED ALL PHILADELPHIA PUBLIC K-8 SCHOOLS. ADOPT-A-SCHOOL PROGRAM SERVED TWO PHILADELPHIA SCHOOLS THIS PAST YEAR.
